



METROPOLITAN TULSA TRANSIT AUTHORITY
BONUS BUCKS AGREEMENT

THIS AGREEMENT is entered into _____(mo/day/yr) by and between METROPOLITAN TULSA TRANSIT AUTHORITY, whose physical address is 510 S. Rockford, Tulsa, Oklahoma, and _____(employer), whose address is _____.

In the consideration of the mutual promises and the terms and conditions set forth herein, the parties agree as follows:

I. Bonus Bucks Program

- A. Employer shall distribute Bonus Bucks in a form prepared by Tulsa Transit to employer's employees and shall pay ___50% or ___100% of the cost of the monthly bus passes upon redemption of the forms. If the employer pays 50%, the employee will also pay 50% of the cost. If 50% is chosen then Tulsa Transit will bill employer for full amount of pass. It will be up to the employer to receive the other portion from employee. Each Bonus Bucks form can be redeemed for one (1) 31-day pass good for unlimited rides on local routes for 31 days (\$45 value), or four (4) 10-ride Regular Fare Cards (\$56 value), four (4) 10-ride Express Fare Cards (\$68 value), or (1) 10 ride Lift Coupons (\$35 value). Bonus Bucks shall have no cash value.
- B. Tulsa Transit shall provide employer with Bonus Bucks form bearing Employer's name and/or logo.
- C. Employees shall redeem the Bonus Bucks by mailing, emailing, or faxing the Bonus Bucks form to Tulsa Transit. Transit shall not provide refunds or credits.
- D. Tulsa Transit shall invoice employer monthly for all Bonus Bucks redeemed. Tulsa Transit shall provide employer with a listing of names written on the Bonus Bucks that were redeemed with the monthly billing. Employer shall remit the purchase balance due to Tulsa Transit within 30 days after the date on Tulsa Transit's invoice.
- E. Tulsa Transit shall maintain redeemed Bonus Bucks for one year. One year after redemption of a Bonus Bucks, employer is barred from disputing the accuracy of a billing regarding the redeemed Bonus Bucks

II. Employer's General Responsibility

Employer shall use its best efforts to promote Bonus Bucks to employees in accordance with the terms of the Agreement, at its location(s) in the Tulsa Transit service area. Employer shall maintain a complete inventory and maintain control over all Bonus Bucks forms in its possession.

III. Term

The term of the agreement shall be from the ___ day of _____, 20___, through the ___ day of _____, 20___. This agreement shall renew automatically for one-year terms unless terminated by one or both parties under this agreement.

Either party may cancel this agreement upon 60 days written notice to the other. Upon termination, undistributed Bonus Bucks must be accounted for and returned to Tulsa Transit.

0IV. Employer is Independent Contractor

Employer shall be an independent contractor for all purposes and shall be entitled to no compensation for services provided hereunder other than that stated herein.

V. Assignment

Employer shall not assign any of its interest in this agreement without Tulsa Transit's prior written consent. Any agreement or assignment in violation of this paragraph shall be void.

VI. Nondiscrimination

During the term of this agreement, Employer shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, disability, age or national origin. Tulsa Transit shall not discriminate against Employer's employees for services provided on the basis of race, religion, color, sex, disability, age or national origin.

VII. Integration and Modification

This agreement includes the entire agreement of the parties and supersedes any prior discussions or agreements regarding the same subject. The agreement may be modified only by a written agreement signed by authorized representative of the parties.

1VIII. Authority

The representatives signing on behalf of the parties certify that the party for which they sign to make this agreement duly authorizes them.

IX. Project Managers

Employer's project manager for this agreement is _____.

X. Liability

Tulsa Transit shall not be liable for consequential or incidental damages arising out of or breach of this agreement.
